Sealed Bids for the City of Three Rivers, Michigan, CWSRF Project No. 5761-01, Contract B – WWTP, will be received by the City of Three Rivers, Michigan at 333 West Michigan Avenue; Three Rivers, Michigan 49093 until 2:00 p.m., local time, on August 3, 2022, at which time they will be publicly opened and read.

A non-mandatory pre-bid meeting will be held at the City of Three Rivers, Michigan, Wastewater Treatment Plant, 409 Wolf Road, Three Rivers, Michigan 49093 at 1:30 pm, Monday, July 18, 2022. Interested bidders are encouraged to attend.

In general, the work consists of replacement of the existing pretreatment (headworks) facility. Proposed improvements include the construction of a new headworks facility including, but not limited to a mechanically cleaned bar screen, washer compacter, tray-style grit removal system, grit pumps and grit classifier, ionization MAU, concrete channels, stop plates, electrical equipment, instrumentation, and appurtenances in an insulated block building. Additional improvements include a dumpster/reserve septage uploading pad, abandonment of the existing pretreatment building, and various sitework and restoration items.


