### ARE YOU INSTALLING **OR** REPLACING AN EXISTING FENCE?

The City of Three Rivers requires residents to obtain zoning approval *prior* to installing or replacing a fence..

**Step One:** Obtain a Zoning Permit from City Hall or the city's website at www.threeriversmi.org/building-permit

**Step Two:** Complete the permit application with the following:

- 1. Include a bird's-eye view drawing (or sketch) showing property lines, location of all buildings on your property, and the desired location of your proposed fence. Also include measurements from the fence to the nearest buildings and property lines.
- 2. Include your fence type (section III) and proposed height under project dimensions (section IV)

**Step Three:** Submit the completed form with your payment and drawing at the City Hall Finance Department (or drop box) or e-mail it to athensmi@safebuilt.com

PLEASE NOTE: privacy fences between your residence and sidewalk (or road right of way) are generally prohibited.

## **TRPD AND ORDINANCE VIOLATIONS**



How does the Three Rivers Police Department handle ordinance violations such as junk vehicles and blight? This duty primarily falls to the Code Enforcement Officer but can be handled by Patrol Officers. The complaints come through Central Dispatch when they are called in by citizens or are seen by Officers as they patrol the neighborhoods.

After seeing an ordinance violation, Code Enforcement will attempt to make contact at the residence to make them aware of the violation. They will then receive a written notice spelling out the violation and that they have 10 days to fix the violation.

After 10 days, the Officer will check for compliance. If the violation was cleaned up, then the complaint is closed out. If the violation has not been corrected, then a clean up will be scheduled and the property owner charged for the clean up and possibly cited.
