Bidding Information

Performance Bids

I. Instructions

- A. Bids must be typewritten or clearly printed in ink and signed by a dulyauthorized representative of the firm submitting the quote.
- B. Bids must be submitted in sealed envelopes, clearly marked on the outside, "Bids for Basement Lighting Project for Three Rivers Public Library".
- C. Bids will be received by the Office of the City Clerk, City Hall, 333 West Michigan Avenue, Three Rivers, Michigan, 49093, until 2:00 p.m. local time, Thursday, April 6, 2023. All bids will be date stamped and time marked when received.
- D. Faxed or emailed bids shall not be accepted.
- E. If you received this document from our website, please fax your contact information to 269-273-1042 so we can place you on the bidders list for addenda.

II. Conditions Applicable to Bids

- A. Applicable Laws: The Ordinances and Charter of the City and laws of the State of Michigan concerning competitive bidding, contracts and purchases will be employed.
- B. Taxes: The City of Three Rivers is generally exempt from Federal Excise and Michigan State Sales Tax. Prices should not include tax.
- C. If the bidder elects to deviate from the specifications stated, all exceptions or other changes must be clearly noted.
- D. The City reserves the right to reject any and all bids, waive informalities or defects in bids, or accept such bids as it shall deem to be in the best interest of the City of Three Rivers.
- E. The City does not discriminate on the basis of race, color, national origin, sex, religion, age or disability in employment or the provision of services.
- F. The Bidder shall provide a completed W-9 form with this bid
- G. The City plans to award the equipment purchase at the **April 25, 2023** Library Board meeting.
- H. All installation work will need to be coordinated with the library director.

Specifications for Lighting

General

The Three Rivers Public library anticipates a summer project to upgrade the lighting in the basement. This is a request for the purchase and installation of new LED panel fixtures at the Three Rivers Public Library.

It is the intent of these specifications to describe the basement lighting needs for our library location.

The below listed specifications and instructions are in no way intended to eliminate any company, vendor, bidder or product from the bid process. It is the sole intent of these specifications and instructions to describe the project that will be the best available fit for the City of Three Rivers and its residents.

Electronic Sign Specifications

Basement Lighting Description

Remove all old strip lights and install new flat panel LED fixtures, lighting controls and occupancy sensors at egress and exits.

The project will include: 29 – 2x4 flat panel LED fixtures, 25 – 8ft LED Strip fixtures, and occupancy sensors and updated switching.

The quote should include removal of all old fixtures and debris, repairs and updates to wiring on lighting circuits, and all labor, materials, disposal costs.

PRICING

- A. Each line item on proposal should clearly list the following information:
 - o Location (Building Name)
 - o Manufacturer
 - o Part Number
 - o Description
 - o Unit Price
 - o Extended Price
 - A proof of the sign proposed
- B. Labor pricing for installation must be listed separate.
- C. Equipment costs should include all mounting hardware, and any other ancillary equipment necessary to mount the equipment.
- D. If applicable, vendor is to specify change fees, freight assurance fees, shipping charges, taxes, surcharges and contingency fees for eligible equipment.
- E. If applicable, vendor is to specify the manufacturer's warranty provided as an integral part of an eligible component without separately identifiable cost.
- F. While price will be the most heavily weighted factor in our evaluation of the bids, the Three Rivers Public Library reserves the right to award the proposal to the best-qualified vendor.
