VOLUNTEER OPPORTUNITIES

BURNING ORDINANCE

- 9:00 AM—7:00 PM Mondays & Wednesdays,
- 9:00 AM—5:00 PM on Saturdays
- Only in approved household outdoor burning container,
- 15 feet away from any building, structure, fence, or other flammable material,
- Supervised at all times,
- Only paper, wood, and/or brush that will not result in a smoldering fire,
- No substance or waste matter shall be burned which discharges a dangerous or poisonous gas, ash, or smoke.

Noxious Grass & Weeds

Property owners are responsible for keeping weeds and/or grass less than 12 inches in height or they will be declared a public nuisance and shall be cut and removed or destroyed by the City and the cost shall be collected as a special assessment on the premise. Do you have some great ideas? Can you commit time each month to your community? The City Commission relies on community volunteers for a variety of services and periodically asks Advisory Boards and Commissions to review programs developed by the City for making recommendations. What the State of Michigan Building Code says...

Any owner or authorized agent who intends to construct,

enlarge, repair, alter, move, demolish or change the occupancy of a building or structure, or to erect, install, enlarge, alter, repair, remove, convert or replace any electrical, gas, mechanical or plumbing system, the installation of which is regulated by city code, or to cause any such work to be done, shall first make application to the building official and obtain the required permits.

- \Rightarrow 4TH DISTRICT leaves out by 7:00 am Wednesday, December 1st for last pick up
- \Rightarrow 2ND DISTRICT leaves out by 7:00 am Monday, December 4 for last pick up
