City of Three Rivers Swartz & Spring Street Reconstruction

Sealed Bids will be received by the **City of Three Rivers** at 333 W. Michigan Ave, Three Rivers, MI 49093 until **2 p.m**. local time, **Thursday, May 16, 2019**, at which time they will be publicly opened and read aloud.

Items of work include approximately 5,600 square yards of HMA removal, 1,350 tons of HMA surface, 5,600 square yards of aggregate base, 2,300 cubic yards of sand subbase, removal and replacement of 1,800 feet of sanitary sewer, 1,800 feet of storm sewer; and 1,800 feet of ductile iron water main including structures and services; 3,500 feet of concrete curb and gutter removal and replacement, concrete drive approach removal and replacement, ADA compliant sidewalk and ramps, tree and stump removal, temporary traffic control, pavement markings, surface restoration and related work.
